#### **General Business:**

Lorraine Rodden asked about the number of trucks removed from the road since the operation of the paste plant.

Ryan Pascoe confirmed that already more than 700 trucks (1400 truck movements) had been removed from the road due to the implementation of the underground emplacement project.

Anthony Barnes tabled a letter to Wollongong City Council from Helensburgh Tigers Rugby League Football Club supporting Metropolitan Coal-funded facility upgrades which would allow the colliery to utilise bathhouse and car parking space during the expansion project. The upgraded facilities would be used for two to three years by the colliery with final custodianship remaining with the Club.

Anthony Barnes indicated that the proposed bathhouse upgrades could be exempt development under the Infrastructure State Environmental Planning Policy (SEPP) and Council development consent would not be required.

Ryan Pascoe provided an update on the Community Consultative Centre saying the Centre fitout was nearing completion.

Ryan Pascoe thanked the committee for all their efforts during the year.

Bob Scullion thanked Ryan Pascoe for stepping in at short notice as a guest speaker for the local Probus Group.
