	about the conditions. BS questioned why there was blast monitoring for only one month while noise was monitored for two.			
KB explained mobile phone reception is required to allow for daily checking of monitor functional available at this monitoring location. A power failure in July resulted in there being no records due therefore the noise monitoring was undertaken over two month period to capture 4 weeks of record agreed with the landowner. BS questioned why there were only four blasts reported on when there that month. KB explained only blasts that received complaints were reported on.				
	7. Attended noise monitoring: BS questioned how the mine chooses its sites and what criteria are used. KB explained sites are selected based on locality and complaints profile, then presented for approval by NSW Department of Planning and Infrastructure (DoPI) via the Noise Management Plan, following consultation with the Environmental Protection Authority (EPA). SL raised concerns about night monitoring in the Wollar publics areas without community knowledge. KB explained that the mine is not generally aware of when the monitoring occurs, thus preventing potential to modify operations during the monitoring, but could investigate notification options with the noise consultant.

<u>Draft Noise Management Plan</u>

- Draft Plan finalised, developed in consultation with the EPA
- Monitoring locations have been changed to reflect changes in land ownership and to be nearer to private residences (refer slide 13)
- Locations of proposed attended noise monitoring site shown
- BS questioned if these would be done bi-monthly CP confirmed they are hoping to be done monthly
- Management Plan to be submitted to DoPI for approval in accordance with Project Approval.

<u> Mine Operations Plan – Review</u>

- Have received verbal approval for Mine Operations Plan (MOP) extension until April 2014
- New MOP will be submitted (in accordance with new guidelines) following approval of S75W Modification
- OEH consulted regarding MOP development

2014 Wilpinjong Exploration Program

<u>ML1573:</u>

- 6 coal quality boreholes
- 5 structural (igneous definition) boreholes
- Up to 84 structural (palaeochannel definition) boreholes
- 2 large diameter coal quality boreholes.

EL7091 (Slate Gully):

- 2 coal quality boreholes
- 1 large diameter coal quality borehole.

<u>EL6169:</u>

- 3 coal quality boreholes
- Site preparation earthworks are planned to commence early December 2013
- Drilling is planned to commence early January 2014
- Drilling is planned to continue for approximately 4 5 months
- Drill crew will be working a 10 days on/4 days off OR Monday to Friday roster
- Operating during daylight hours only.

2013 Ground Geophysics

Ground geophysics is required to assist in surface exploration mapping
 The geophysical tool used is a passive surface electromagnetic device that uses a single frequency to identify unconsolidated alluvial deposits vs. consolidated rock and coal seams
• Will be used to establish depths at which paleochannel material cuts through target coal seams south of Pit 5
• Will also be used to confirm theories of an igneous intrusion based on variation in rock types north of Pit 3.

<u>Future Extensions – Wilpinjong Extension Project</u>
Mine planning progressing
 Environmental baseline studies commenced in November 2013 including agricultural resources, groundwater and geochemistry
Commencing Gateway Site Verification process. JL explained there is a new process to determine if the proposed
project is on strategic agriculture lands. A Gateway Certificate application will be lodged with Government in early 2014 and also made available to the CCC
 Groundwater monitoring network extensions near completion
Additional surface water quality monitoring site established in Slate Gully
Lodgment of EIS proposed in Q4 2015
Groundwater Monitoring Network (GWMN) Extension
 Piezos that Wilpinjong had installed were dominated by Wilpinjong Creek, data was adequate to assist the supporting model
 The expanded GWMN is monitoring alluviums, fractured rock, coal reserve, water levels under infrastructure areas,
tailings dam monitoring, all other holes. The piezos installed have data loggers in them
• JL discussed how Wilpinjong is currently reviewing water licences and licencing the relevant networks – alluvial
piezos covered under the <i>Water Management Act 2000</i> do not need to be licenced.
 SL identified there is no groundwater monitoring to the south of the village and questioned whether Wilpinjong is interested in the water from that end of town. JL explained the seam outcrops in the south and therefore the model
demonstrates there would likely be no impact. SL advised he had concerns as Ulan didn't install bores for many
years and it was evident there was an impact. JL confirmed future bores have not been ruled out. BS questioned how
often the model is recalibrated; JL explained it is recalibrated when there is a change to the mine plan or an
anomaly. Currently it is being recalibrated for the Wilpinjong Extension project.

Land Management

• The 2013 St John's Wort weed control program has commenced around the mine and includes some road reserves. Poor seasonal conditions have led to a lot of weeds. Concerns were raised regarding Saffron thistle down near Cumbo Creek – JL discussed that Saffron thistle is an indicator of competition resulting either from over grazing or extended dry periods affecting plant growth. It was confirmed that anybody that leases land from Peabody is obligated to maintain the land.

Tree Line Project

- Preparation will commence on 2.5km of tree line corridors to be planted in 2014.
- Trees native to the area will be planted to provide a connective corridor between remnant areas of vegetation.

Crown Road Closures

- Applications to close roads were submitted in 2006 by Wilpinjong and MWRC
- Council and Crown roads within mining areas
- Crown Lands restructured in 2007 and applications were misplaced
- When reviewing the status of the roads this year the error was identified
- Crown Lands have located the paper work and are in the process of re-advertising the Crown road closures
- Notice of proposed road closure was advertised in the Mudgee Guardian on the 22nd November 2013

Community Issues

- Wollar Shop lease renewed with Kim Peach
- Ulan Road upgrade- road works will commence soon with the recent money received by Mid-Western Regional Council (MWRC) from the State Government.
- Three mines and MWRC working towards developing an implementation agreement detailing how the Ulan Road Strategy will work
- Investigating the opportunity to demolish the burnt house at the entrance to Wollar. There is a standing issue with where to take the waste as it cannot all be taken to the Mudgee tip. The mine only holds an EPL approval to dump and restricted amount of large tyres in pit. The section 75W is seeking approval to allow disposal of inert building waste from Peabody houses in the pit as well. Any demolition program will be undertaken by a licensed person and waste will be appropriately separated.
 - o It was suggested there could be a fire training program on an asbestos house that is to be demolished.

General Business: BS raised a question about the term 'extreme weather events' KB confirmed 'extreme weather events'are being investigated as part of a new Pollution Reduction Program (PRP) condition within Wilpinjong's EPL, currently operating using the existing dust Trigger Action Response Protocol (TARP) whilst developing the PRP.

- JW raised that in the future closure of the mine, it is important that fire trails are left through the rehabilitated areas. It was confirmed that these factors are included in future planning.
- BH raised concern about the grazing around the Wollar Creek JL confirmed that overstocking will not be tolerated and proper grazing techniques will be used.
